

Sub: Submission of Division-wise Annual Works Plan for PWD, GNCTD

It was directed by the Pr. Secretary, PWD vide order no. F 4(60)/2023-24/PWD-II/Roads/dspwd 2/7785-7291 dt. 28.11.2023 that no new work for repair and maintenance shall be undertaken till the submission of Division wise Annual Action Plan as well as comprehensive maintenance Plan in respect of all kind of works pertaining to Buildings, Roads and flyovers etc. This office also directed vide OM No. E-in-C/PWD/Works/OO/2023/6787 dt. 01.12.2023 that the directions issued by the Pr. Secretary shall be strictly complied. However, Annual Action plan has not yet been received in this office. It has also been noted by the Pr. Secretary, PWD in a file CD No. 057579568 regarding Delegation of Financial Powers to HoDs & Administrative departments of GNCTD that:-

"Works ordinarily have to be carried out as per Annual Works Plan which is yet to be firmed up in PWD. In the first instance, PWD Secretariat shall ensure finalising of Annual Works Plan".

Therefore, it is directed that Annual Works Plan shall be finalized by all CEs and submitted to this office in compliance of above said orders/directions.
