MOU with client Dept. shall also be signed and followed as per CPWD Works Manual Para-3.1.1.1(2) & para 3.1.2.1 (5) & (6). In this regard the provisions as per Annexure-3 and Annexure-4 of CPWD Works Manual shall be followed.
