CIRCULAR

Sub: Advisory on phasing out Single Use Plastic (SUP) items in Govt. Offices situated in MSO Building, IP Estate, New Delhi-110002.

The Department of Environment, Govt of NCT of Delhi vide no. F.12 (651)/Env/SLMC/Committee-on-SUP/2021/4396-4407 dated 28.10.2021 had issued an advisory regarding phasing out Single use Plastic (SUP) items in government offices of Govt of NCT of Delhi.

The Single Use Plastic (SUP) items being non-biodegradable, their presence in Municipal Solid Waste creates anaerobic conditions and inhibits the process of composting and natural decay and therefore, causes foul smell too. In order to prevent adverse effects on human beings, cattle population, soil, ecology and environment, all Delhi Govt Departments/Boards situated in MSO Building are hereby advised to discourage use of following single use plastic items and adopt use of their alternatives as listed below, in public interest at large:

The DDOs/Treasury officers shall not entertain/process bills that reflect expenditure on the use of aforesaid plastic made articles in government offices. Directions in this regard shall also circulated by the Head of Department to all line department/subordinate offices for strict compliance.

Further, it is advised only that multi-use water bottles/ dispensers/containers should be used in government offices and use of water bottles of alternative materials like Glass, Steel, Aluminium etc. may be encouraged.

Hence, it is reiterated that all the HoDs of Department/Boards shall take stringent measures to ensure that the SUP items shall not be used in the premises of MSO Building and their staff should adopt the alternatives as listed above.

This is being issued with prior approval of Pr. Secretary, PWD.
