Subject : Regarding assigning additional charge/Temporary charge at the level of E-in-C/Chief Engineer.

Sir,

1. It has come to the notice that few engineering officers (Assistant Engineer and above level officer) have been given additional charge/temporary charge at the level of Engineer-in-Chief/Chief Engineer without taking prior approval of competent authority. This is not desirable and Pr. Secretary(PWD) has taken a very serious view of this unwarranted lapse.
2. It is hereby directed that **henceforth**, no such orders shall be issued by E-in-C or CE or any other senior Engineering officer at their own level without seeking approval from the competent authority. Also, all such cases, where orders have already been issued by the E-in-C or CE, shall be put up in PWD Secretariat administration branch, after following the due procedure as prescribed from time to time, for seeking approval of competent authority. E-in-C shall disseminate this order among all senior officers working under him for strict compliance.
