OFFICE MEMORANDUM

Sub.- Non-Implementation of transfer orders – relieving of transferred officers regarding

It is reiterated that annual rotational transfer/posting orders and review of the representations of O.S/J.H.T/U.D.C/L.D.C have been issued by this office with the approval of competent authority. These orders have to be implemented immediately or within a reasonable time, as mentioned in office order.

In this matter also refer to this office O.M. issued vide 21(1)/CE(Works cum TLQA)/Coord(NR)/EE-2/E-I/2792 dated 09/10/2024, even No. 2831 dated 16/10/2024 and 21(22)/CE(WcumTLQA)/Coord(NR)/EE(C-3)/2024/3090 dated 12/12/2024 vide which it was directed to relieve the officers transferred till date immediately without waiting for their substitute by making local arrangements.

Despite clear instructions, the transfer orders of various officers/officials have not been implemented fully even after lapse of dates mentioned in their transfer orders and directions in above said O.Ms. This has badly affected the progress of various officers. This has been viewed seriously the Competent Authority. Non-relieving of these officers/officials is clear-cut violation of transfer/probity guidelines and guidelines issued by the Directorate time to time.

It is pertinent to note that the staff strength available with NR across all categories is approximately 75% or less of the sanctioned strength. Consequently, the coordination unit (NR) allocates staff to units in a proportionate ratio, commensurate with the available staff strength.

Hence, all the Controlling authorities are once again directed to relieve the transferred officers/officials without waiting for their substitute within 10 days from the issue of this O.M., otherwise action may be initiated against the transferred employees and relieving officers in compliance to D.G., CPWD various guidelines received from time to time. Also, the transferred officials shall stand relieved through PIMS after the lapse of above said 10 days. The controlling officers are directed to ensure that the salary of these officials are not been drawn by the present office/units through PFMS from the date of their relieving.

This issues with the approval of Competent Authority.


