

Sir,

1. Kindly refer to DOV's letter No.F.2(15)/2013/DOV/ dated 13/03/2015 and DOV's letter No. F.2(15)/2013/DOV/3030/605-622 dated 22.02.2017, on the subject cited above.

2. Accordingly, you are requested to supply a date-wise list of officers/officials, containing **names, mobile numbers and residential address** of each officers/officials for Punch Witness duty in Anti Corruption Branch for the entire month of **April-2025 i.e. 01.04.2025 to 30.04.2025 in a sealed envelope**. The list should contains both Non-Gazetted and Gazetted (not below the Group-C service) officials / officers for each day. The officials/officer has to be deployed for punch witness duty whom has to report to Duty officer, Anti Corruption Branch, Vikas Bhawan-2, 5th Floor, Upper Bela Road, Civil Lines, Delhi at 9-30 AM sharp on scheduled date and has to remain present till 6.-00 PM, after 6 PM to 9.30 am (next day), he/she will remain present at his/her residential address alert on his/her mobile/landline phones so that he/she may be called in A.C.B. for official duty, if service is required during that period.


3. Each department has to depute one official/officer for each day for the whole month of **April-2025**. The ratio of Gazetted and non-Gazetted officers for the whole month has to be decided by the Competent Authorities of the concerned department. Besides the above list containing names of officer/officials Concerned Department should keep one G.O. for reserve duty who may be called, if any action requires the presence of Gazetted Officer mandatorily.

4. Thus, the department has to supply two lists one list containing the names of Non- Gazetted and Gazetted officers whom has to report to ACB on daily basis as mentioned at para-2.

5 The second list will be of those Gazetted officers who have been put on reserved duty and may be called, if required.

6 ***In case any officer/official (deputed for panch witness duty) is on Leave/Transfer/Promotion/Retired then this branch may please be informed well in advance along with the name of proposed suitable substitute official h residential address/official address as well as Telephone Nos.***

NOTE: - KINDLY ENSURE THAT NO OFFICIAL IS DEPUTED FOR PANCH WITNESS DUTY IN ACB AGAINST WHOM ANY CRIMINAL CASE OR DOUBTFUL INTEGRITY PENDING.
