Sir/Madam.

It is stated that Civil Services (Preliminary) Examination-2025 will be conducted by the Union Public Service Commission (UPSC) on 25.05.2025 (Sunday). In this regard, UPSC has sent a communication to this Department, seeking assistance of this Government for smooth conduct of the examination.

Inter-alia, UPSC has requisitioned vehicles to be placed on duty on 25.05.2025 (Sunday). Accordingly, I am directed to request you that necessary directions may be issued to forward details of three vehicles belonging to the department along with the details of the drivers. It is pertinent to mention here that UPSC will attach these vehicles with the deployed zonal officers who are senior officers in various Ministries/Departments of Govt. of India and other Government organizations. Hence, the vehicles so deployed, preferably Ertiga/Innova/Maruti SX4/Ciaz etc. should be in good working condition, fit in all respects with a fully filled fuel tank. These vehicles are to reach the UPSC at 4:30 A.M. on 25.05.2025 positively.

It is also requested that a Nodal Officer in the department may be appointed for this purpose whose name will also be forwarded to UPSC so that UPSC may establish direct contact with the department in respect to the vehicles of the department.
