## OFFICE MEMORENDUM

(NOTICE FOR VACANCY)

Sub: Filling of one post Superintending Engineer/ Additional Chief Engineer on deputation basis in Public Works Department of Govt. of NCT of Delhi.

It is proposed to fill up one post of Superintending Engineer or Additional Chief Engineer in PWD for "Infrastructure Planning & Design", in the scale PB-4 37400-67000 (GP 8700).

The eligibility conditions are as under:-

Eligibility: Officer belonging to Group A (direct recruitment) service of IRSE, CES, MOST having total experience of 15 years or more and presently working on analogous post in the scale PB-3, 15600-39100 (GP 7600) or in PB-4, 37400-67000 (GP 8700). Out of total 15 years, at least five years experience should be in the design of infrastructure related project works such as ROBs, RUBs, Grade separations, Tunnels, Railway projects etc. Officers having experience of dealing with multi aspects of civil engineering would be preferred. Experience of legal aspects of contracts etc. would be desirable. Since the post would carry non-sensitive work of planning & design, vigilance clearance would not be essential (for otherwise suitable candidates) but desirable condition. However officer having pending CBI/ACB cases would not be considered;

**Period of deputation:** Three years extendible for one more year. The Govt. of NCT of Delhi reserves the right to repatriate the deputationist before three years. The maximum age limit for appointment by deputation shall be, not exceeding 46 years, as on closing date of receipt of applications).

Eligible officers may forward the application to undersigned through their controlling authority alongwith ACRs gradation for the last five years & IC/VC etc. alongwith Bio-data. The last date receiving of applications is 16/12/2015. Willing candidates may also send an advance copy of their application directly to the undersigned for consideration, to avoid delay
