In regard to cases of disabled persons, it was decided that rather than considering their cases in Medical Committee, the disabled officials covered as per the notification dated. 21st November 2014. If have disability certificate issued by the authorised hospitals/ authority, accordingly to order of Health & Family Welfare Department, G.N.C.T. Delhi, their cases may be considered administratively after going through the authenticity or verification of their disability certificate.

The earlier meeting of the Medical Committee took place on 6-8-15 and accordingly the waiting list of eligible persons was prepared and exists till now. The applicant found eligible for allotment by the Medical Committee in the meeting on 19-4-2016 (Tuesday) & 11-5-16 (Wednesday) would be added to the existing waiting list.

It was decided that allotment of the Govt. Flats be done to aforesaid eligible official in respective category on the basis of their date of priority and if the official fail to accept the allotted flat within the time period stipulated, the allotment of the flat would be subsequently offered to next in the waiting list and this list would be remained in operation up till one year or next meeting in this regard whichever is earlier.
