



Public Works Department Manuals as was issued by CPWD vide office memorandum no. DG/SE/CM/CON/286 dated 30/06/2015 (copy enclosed) to ensure more effective and efficient compliance of the statutory provisions and ensure coverage of social security benefits to all the eligible employees.
