

As you are aware GST has been implemented w.e.f. 1<sup>st</sup> July 2017 and tax deduction at source (TDS) is an important aspect of GST. In this regard registration of the existing TAN holders is likely to start shortly on the GSTN Portal <a href="https://www.gst.gov.in">www.gst.gov.in</a>. Registration of TAN holders under GSTN Portal and deduction of tax at source is mandatory under Section 51 of the Goods and Service Tax Act, 2017 and, therefore, it is imperative on your Departments part to immediately take steps for the registration and further to deduct tax at source as per Goods & Service Tax Act, 2017.

In this regard, Department of Trade & Taxes is organizing an orientation programme on 15<sup>th</sup> July, 2017 at Vyapar Bhawan, Department of Trade & Taxes, I P Estate, New Delhi-110002. A nodal officer (DDO) from your Department may please be nominated for this training programme.
