Sir,

We are the association of the Ready Mix concrete manufacture in Delhi and NCR We are supplying the RMC for the various govt projects in Delhi. We are also in the approved list of suppliers of various govt department such as DSIIDC, NDMC, I & Flood control department & MCD. We have approached to PWD department for approval of our RMC plant but the system followed by the PWD department for vendor registration having a lot of confusion and mismanagement. The E & C office instructed us to contact with the chief Engineers of the respective divisions and chief engineers says that we have to contact with the superintendent Engineers . The S.E.s' again refer us to the Chief Engineers . We have noticed that the NIT's invited by the various division mentioned the name of approved RMC suppliers depend on the tender inviting division. However no one in PWD dept able to give us the information about the authority and procedure for selecting the RMC suppliers for the works awarded by the Public work department. It seems that there is no centralized system for approving the suppliers and only the tender inviting authority taking the decision about the matter. Unlike the PWD department the other govt department having a clear & transparent procedure

like plant visit, quality testing, machinery and equipment verification and a centralized vender approval system. After getting approval we can able to supply the RMC in all the divisions of these dept.

But here in PWD we are moving window to window to get our plant approved but no clear guidelines is available with the department. Due to above mismanagement the corrupt official taking advantage by giving benefit to the big players and creating monopoly in the field of Ready Mix concrete this monopoly became the cause of losses to the department.

You are requested to take action.



Kindly refer the letter mentioned above addressed to Hon'ble Minister, PWD and copy endorsed to E-in-C, this office and other CEs & SEs. In this context, it is submitted that the major work of concreting, by obtaining RMC, is with Project Units. The Maintenance Units do not have bulk concreting under them. The selection of approved vendors of RMC should therefore be assigned to the C.E. (Project) who have resources available for inspection of RMC plants and decide after inspection of quality, plant & machinery whether the vendor is fit for the approval or not. The Maintenance Units are completely engrossed with day to day problems of maintenance issues such as potholes, horticulture, street light, mohalla clinics and host of other issues. Therefore, the Project Unit can find time for the selection of approved agencies for RMC as the same pertains majorly in their area of activity.

It is, therefore, requested to kindly issue orders for assigning the task for deciding the approved RMC agencies to the Chief Engineer (Project).
