## I. Public Works Department

### A. Strengthening of ring road from AIIMS to Ashram

(i) The Chief Engineer, Public Works Department has submitted that the preliminary estimate for strengthening of ring road from AIIMS to Ashram (5.6 KM) at an estimated cost of ₹15.63 crore is based on DSR 2014 minus 12% for scheduled items and market rates for non-scheduled items with 1% each for contingency, labour cess, third (3<sup>rd</sup>) party quality control including maintenance period of three (03) years. It was stated that last strengthening of the road was carried out before October 2010 and road surface has outlived its useful life. Detail of the proposal is as under:

(ii) After considering the recommendation of Administrative Department on the requirement and its satisfaction regarding technical, administrative, operative, maintenance and financial aspects etc, the Expenditure Finance Committee approved and sanctioned the proposal of the department. - ii. The tender shall be invited as per the approved cost considered on the recommendation of the department.
- iii. Compliance of pre-sanction / post-sanction guidelines / requirement circulated as Annexure to Government order no. PA/DSF/Misc/2012-13/Exp-4/538-45 dated 17.05.2012 during planning and execution period

## II. Environment and Forests Department

### A. Extension of project period for rehabilitation of degraded forest land in the Southern Ridge area of Asola Bhatti, Dera Mandi, Maidangarhi, Ghittorni and Rajokri through Eco Task Force from 1.4.2017 to 31.3.2022

(i) The Secretary, department of Environment and Forests has submitted that the proposal is for continuance of 132 Eco Task Force (Territorial Army) for further period of five (05) years from 1.4.2017 to 31.3.2022 for improving and sustaining the wildlife habitat through plantation in Asola/Bhatti and Dera Mandi areas. The proposal was earlier placed in the 1<sup>st</sup> meeting of Expenditure Finance Committee held on September 22, 2017. During deliberation, it was observed by the Committee that the cost of plantation and other related components, number of persons deployed, etc shall be reviewed first at the level of Pr. Secretary (Finance) before consideration of the same by the Expenditure Finance Committee.


(ii) Accordingly, a review meeting was taken by the Pr. Secretary (Finance) on 31.10.2017. The Forest department was directed to relook the component of maintenance afresh and submit a comprehensive proposal with justification. Accordingly, Forest department reviewed the proposal particularly the maintenance part and recalculated the cost of creation of saplings. Now, the expenditure for creation of a sapling has been reduced to ₹202/- per sapling. Now the cost of rehabilitation has been reduced to ₹90.25 crore from ₹98.47 crore. The details of project cost is as under;

05. Thereafter, meeting ended with vote of thanks to the Chair.


