Sub:- Recarpeting of various roads under U.P.Government in Okhla Constituency.

In pursuance to the proposal of Chief Engineer (South), PWD vide U.O. No. 23(155)/A-116/CE South(M)/PWD/53 dated 12/01/2018, I have been directed to convey the Administrative Approval & Expenditure Sanction of Pr. CE(M),PWD, GNCTD for carrying out the work for **Recarpeting of various roads under U.P.Government in Okhla Constituency.** for an estimated cost of Rs. 2,49,04,280/- (Rupees Two Crore, Forty Nine Lakh, Four Thousand and Two Hundred Eighty only), subject to the following conditions:-

1. Availability of fund under relevant Head of Account during the current financial year 2017-18.
2. The work shall be executed by U.P.Irrigation Department, as a deposit work.
3. No escalation in cost will be allowed.

5. Observance of requisite codal formalities as per GFR-2017, CPWD Work Manual and various instructions issued by the Finance Department, GNCTD/Govt. of India time to time.
6. The completion report/certificate will be submitted to Pr.Secretary, PWD, Planning and Finance Deptt., this office immediately after the work is completed but within the stipulated period. The date of start of the work may also be intimated.
7. The monthly progress report for all the roads will be submitted separately to this office on regular basis.
8. Chief Engineer(South) will furnish the copy agreement executed with agency to this office immediately after award of work.
9. Fund utilization certificate may also be furnished to this office.
10. This issues with "in principal approval" received vide No.45/AAO(Road) dt.09.01.2018 from Pr.Secretary, PWD for the work of carpeting of various roads under U.P. Government in Okhla Constituency.
11. This issue with the approval of Pr. CE(M), PWD in U.O. No. 23(155)/A-116/CE South(M)/PWD/53 dated 12/01/2018 (NP 1 to 9)
