ORDER

विषय:- Construction of FOB for passage from Type-III to Type-IV Quarters, D.A. Flats, Haiderpur, Shalimar Bagh, Delhi

The Administrative Approval/Expenditure sanction for carrying out the work of **Construction of FOB for passage from Type-III to Type-IV Quarters, D.A. Flats, Haiderpur, Shalimar Bagh, Delhi** for an estimated cost of **Rs. 5,94,100/-** is hereby accorded as per financial powers delegated to Engineering officers of PWD Delhi for undertaking capital works vide Finance (Infra) Deptt. PWD No. **8(2)/2007-AC/Finance/01295543/JSFINA/1148-1166** dated **12.10.2017** subject to the following conditions.

1. The expenditure involved is debitable to the Major Head 2216 Housing sub head 870027-Delhi Govt. Staff Quarters from within the sanctioned budget allotment for financial year 2017-18 and subsequent years subject to availability of funds. However before incurring any expenditure, Engineer-in-Charge must ensure that all requisite codal formalities as per GFR-2005, CPWD work manual. Instruction of Finance Department, GNCTD, GOI and CVC guidelines have been observed.
2. A/A & E/S has been accorded purely based on the estimated calculations however, the detailed requirement such as quantity, rates and its technical specification, feasibility, necessity etc. for each component shall be worked out at the stage of preparing detailed estimate/ technical sanction/ NIT by the competent Authority.
3. The tender shall be invited as per the approved cost based on DSR-2014
4. Works shall be completed within the given time frame and within the sanctioned cost.
5. Financing the works shall be managed by the Engineer-in-charge as per the provisions made in its budget for respective works/ components.
6. The Engineer-in-Charge and/or construction agency must not change the scope of work in any manner as indicated in the Preliminary Estimate cum Detailed Estimate without approved of the competent authority.
7. Engineer-in-Charge / construction agency may identify the probable impediments in the execution of projects well in advance and may project contingent measures/ plans as identified to deal with them, so as to ensure completion of the projects as per approved time schedule.
8. It will be ensured that all the payments to contractors are made through electronic fund transfer only.


9. The Engineer-in-charge will ensure that after A/A & E/S of Preliminary Estimate cum Detailed Estimate, the details like name of work, estimated cost, awarded cost, work completion cost, work start date, completion date, name of agency must be uploaded on the website of the department..
10. No escalation in sanctioned cost shall be permitted.
11. Tenders shall be invited by way of e-tendering and wide publicity may also be given as per GFR 2005/CPWD work manual.
12. The sanction for each of the proposal shall not be sub divided for tender purpose except horticulture work in one sanction.
13. The provision made for each of the electrical/horticulture shall be utilized for the specific purpose only. Inter-change of provision shall not be resorted to.

The expenditure involved is debitable to Major Head 2216 Housing sub head 870027-Delhi Govt. Staff Quarters from and within sanction budget allotment for financial year 2017-18 and subsequent years subject to availability of funds and compliance of codal formalities.
