Amounting to Rs. 4,92,81,700/-

In pursuance to the proposal of Pr. Chief Enginer (Maintenance), PWD (GNCTD) vide UO note No. 23(1)/Pr.CE(M)/PWD/1424 dated 06.04.2018, I am directed to convey the Administrative Approval and Expenditure Sanction of Engineer-in-Chief, PWD for carrying out the work for "Strengthening of various roads and construction of footpath & drain at Authority Road Janakpuri, Strengthening of Vedic Marg from Tihar crossing to community hall, B2 Block Sabzi Mandi Road Janakpuri, Mota Singh Marg Janakpuri, Authority Road Janakpuri, Road No. 237 Vikaspuri, Nazafgarh Road to A-71 Rajouri Garden, Ring Road to A-31 Rajouri Garden, 20-Block Tilak Vihar Road, Ashoka Road/Radhaswami Satsang Marg & Tilak Nagar Main Market Road under PWD Division WR-1, New Delhi." for an estimated cost of Rs. 4,92,81,700/- (Rs. Four Crore Ninety Two Lakhs Eighty one Thousand Seven Hundred only) subjected to the following terms and conditions:-

- 1. The expenditure involved is debitable to the Budget Head-5054- 04-337- 94 00 53-Strengthening/Resurfacing/Microsurfacing of PWD roads (Roads with ROW< 30 Mtrs) from within the sanctioned budget allotment for the current financial year 2018-19 subject to availability of funds. However, before incurring any expenditure, Engineer-in-Charge must ensure that all requisite codal formalities as per GFR-2017, CPWD works manual, Instruction of Finance Department, GNCTD, GOI and CVC guidelines have been observed.
- 2. A/A & E/S has been accorded purely based on the estimated calculations submitted by the Pr.CE(M), PWD (GNCTD). However, the detailed requirement such as quantity, rates and its technical specification, feasibility, necessity etc. for each project shall be worked out by the Competent Authority at the stage of preparing detailed estimate/ technical sanction and competent TS Authority is responsible for the same.

Amounting to Rs. 4,92,81,700/-
- It may be ensured before awarding the work that if any drain work comes under the jurisdiction of PWD, design and execution of the work should be adequate and techno 3. economically optimum and it shall be ensured that water logging does not taken place and the objectives of the work are fulfilled.

Works shall be completed as per approved Scope of works at the sanctioned cost within 4. the stipulated period. No cost escalation will be considered in future.

The tender shall be invited as per the approved cost based on DSR-2014 minus 12%. 5.

Compliance of pre sanction/post sanction guidelines/requirement circulated as 6. Annexure to Government order no. PA.DSF/Misc/2012-13/Exp-4/538-45 dated 17.05.2012 during planning and execution period.

The contingencies should be restricted to original PE. 7.

Financing the works shall be managed by the Engineer-in-Charge as per the provisions 8. made in its budget for respective works.

The Engineer-in-Charge and /or construction agency must not change the scope fo work 9. in any manner as indicated in the Preliminary Estimate without approval of the

Competent Authority.

- Engineer-in-Charge/ construction agency may identify the probable impediments in the 10. execution of Work well in advance and may project contingent measures/ plans as identified to deal with them, so as to ensure completion of the work as per approved time schedule.
- Work completion certificate and copy of the 3rd party Quality Control Certificate (if 11. applicable) may be furnished to Chief Engineer which in turn will apprise the Pr.CE(M) & Engineer-in-Chief, PWD (GNCTD) of the completion of work as per prescribed standards and schedule.
- The Construction Agency shall submit the final bill to Engineer-in-Chief reporting 12. utilization of funds, completion of work and settlement of advance/ deposit money on the completion of the work/ project.

It will be ensured that all the payments to contractors are made through electronic fund 13.

transfer only.

The concerned Engineer/ Contractor shall ensure that the quality of the road shall be as 14. per standards prescribed and no strengthening works on these roads will be allowed

before 5 years.

Chief Engineer will ensure that after A/A & E/S of PE, the details - name of work, length, 15. starting and ending point, estimated cost, awarded cost, work completion cost, work start date, completion date, name of agency along with a copy of estimate must be uploaded on the website of the department. Further a small plaque be set up on road site, mentioning agency, date and cost of completion and length of road etc.

- Tenders shall be invited by way of e-tendering and wide publicity may also be given as 16. per GFR 2017/CPWD Work manual.

The sanction for each of the proposal shall not be sub-divided for tender purpose where 17.

cluster or roads have been included in one sanction.

No expenditure from revenue head shall be incurred in respect of the maintenance of 18. the aforesaid roads during the maintenance period/paid maintenance period with the contractors.

Pr. Chief Engineer/Chief Engineer shall enter into comprehensive Contract with 19. contractors incorporating the provisions for maintenance as per the provisions in the estimates. Performance guarantee in the shape of Security deposit shall be kept for maintenance period also.

Pr. Chief Engineer/Chief Engineer shall submit quarterly monitoring report and annual 20. performance report/work completion report within 15 days of completion of the

quarter/year/completion of the project as the case may be.

This sanction issues with the approval of E-in-C, PWD (GNCTD) vide U.O. No. 21. 23(1)/Pr.CE(M)/PWD/1424 dated 06.04.2018 (NP-1 to 9) and with the approval of Director (Works and Establishment) on page NP-9.
