A meeting was held on **04.08.2018** at **12.00 Hours** under the chairmanship of Hon'ble Minister (UD/PWD) in his Conference Room at Level-7 to discuss the **Issues relating to Digging & Restoration of Roads**. The officers who attended the meeting are as per Annexure 'A'. The following issues were discussed:

1. **Specifications for Restoration Work:** After due deliberations it was decided as under:
 - (i) **RMC Roads & Pavements:** The mix of RMC to be used shall be M-30 & the thickness of layer shall be the same as was cut.
 - (ii) **Bituminous Roads:** The specifications of pavement/ roads shall be the same as was cut.

2. **3rd Party Quality Assurance Teams:** It was decided that TPQA teams empanelled by PWD, DMCs e.g. IIT, CRRI, CBRI, DTU & NCCBM & other Govt. agencies as approved by the competent authority shall be engaged.


The representatives of MCD present in the meeting affirmed that they don't have any objection to above engagement of TPQA.

3. **On Line Road Cutting Permission:** The officials of DJB informed that they are not getting on line permission for road cutting. The PWD officials stated that there is no application pending from DJB. It was decided that DJB may apply for road cutting without deposition of any road charges. In case of roads under the PWD, the same will be restored by PWD after issuance of a completion certificate by DJB. The PWD shall recover the restoration charges at the end of each Financial Year. In case of roads under the jurisdiction DMC, DJB shall cut & restore the roads.

4. **NOCs by Road Owning Agency:** The application shall be submitted by the user Department to the Road Owning Agency (ROA) for obtaining NOC for cutting the road. The ROA shall carry out the inspection within 7 days of the receipt of application & NOC be issued within 2 weeks of receipt of application. In case of no permission from ROA, the NOC shall be deemed to have been granted.

It was decided that the user department will carry out the work within the period of permission and intimate the completion of the works to the road owning agency.

It was explained by the representative of DJB that the contractors do not come for small repair works. The Hon'ble Minister decided that some contractors may be empanelled for carrying out repair work and running contract may be entered upon with them.
