In partial modification of earlier order No. F.4 (Type-V)/Allotment/ PWD /2014/9802-9818 dated 28/08/2014, the license fees for the Gulabi Bagh, Type-IV Delhi Administration Flats No. 2009, 2013, 2017, 2021, 2027, 2031, 2035 & 2039 to 2098 (67 Flats) may be read as Rs.625/- per month instead of Rs. 875/- per month, w.e.f. 01.09.2014.

The rest contents of the said orders will remain unchanged. As a consequences higher amount deducted in respect of licence fee as stated above, may be adjusted accordingly.
