

Subject: Training-cum-orientation programme for the Cheque Drawing DDOs on 20.09.2018.

Sir,


As you are aware that Goods and Services Tax has been implemented w.e.f. 1st July, 2017 and the necessary legislations such as The Central Goods & Services Tax Act (CGST), Delhi Goods and Services Tax Act (DGST), Integrated Goods and Services Tax Act (IGST) etc. have come into effect mandating compulsory registration and deduction of tax at source (TDS) by the government organizations. I would like to draw your kind attention to Section 51 of DGST/CGST Act under which every government department or establishment of Central/State or local authorities or government agencies are required to deduct tax at source @ 1% under the State and Central laws where the taxable transaction value of goods and /or services exceeds 2.5 lakhs. The government has appointed first day of October, 2018 as the day on which the provisions of section-51 of the said Act shall come into force.

Under Section 24 of the above referred Acts, every TDS deductor is required to obtain registration through the GST common portal (www.gst.gov.in). Registration window is likely to be enabled by 1st October, 2018, therefore, all government establishments/ DDOs are required to obtain the registration under the GST Act and deduct tax at source as per law.

In this regard, a training-cum-orientation programme for all the 57 Cheque drawing DDOs -only of your department will be organized at 11.00 am on 20.09.2018 (Thursday) in the Conference Hall at 13th floor of Department of Trade & Taxes, Vyapar Bhawan, I.P. Estate, New Delhi. **Other DDOs who are not responsible for making payments to suppliers should not be sent for said training. Training to other DDOs may be given by the DDOs who will be trained in this training.**

You are, therefore, requested to direct all the Cheque Drawing DDOs of your Department to attend the above-mentioned training-cum-orientation programme.
