Providing & fixing of Jersey Barrier and other Minor Engineering Works at Princess Road Sub.: from Model Town I Red Light to PCR Gate under Sub Division NR-12.

I am directed to convey the Administrative Approval/Expenditure sanction of Superintending Engineer (North) PWD for carrying out the work for providing & fixing of Jersey Barrier and other Minor Engineering Works at Princess Road from Model Town I Red Light to PCR Gate under Sub Division NR-12 for an estimated cost of Rs. 41,38,400/- (Forty One Lakh Thirty Eight Thousand Four Hundred Only) as per financial powers delegated to Engineering officers of PWD, Delhi for undertaking capital works vide Finance (infra) Deptt. PWD No. 8(2)/2007-AC/Finance/01295543/JSFINA/1148-1166 dated 12.10.2017 subject to the following conditions:

- The expenditure involved is debitable to the Major Head 5054 04 101 "Road and Bridges (Non-Plan)" Sub-Head 94 00 53 from within the sanctioned budget allotment for the current financial year 2018-19 subject to availability of funds. However before incurring any expenditure, Engineer-in-Charge must ensure that all requisite codal formalities as per GFR-2005, CPWD Works Manual. Instruction of Finance Department, GNCTD, GOI and CVC guidelines have been observed.
- A/A & E/S has been accorded purely based on the estimated calculation submitted by the Executive Engineer, North Roads Division (M-313). However, the detailed requirement such as quantity, rates and its technical specification, feasibility, necessity etc. for each component shall be worked out by the Executive Engineer, North Road, Executive Engineer, North Electrical and Deputy Director Horticulture (North) at the stage of preparing detailed estimate/ technical sanction/NIT/Justification
- The tender shall be invited as per the approved cost based on DSR-2016 including prevailing cost 3. index, (-) 9.5% as per GNCTD circular. 4.
- Works shall be completed within the given time frame and within the sanctioned cost.
- Financing the works shall be managed by the Engineer-in-Charge as per the provisions made in its budget for respective works/ components.
- The Engineer-in-Charge and / or construction agency must not change the scope of work in any manner as indicated in the Preliminary Estimate cum Detailed Estimate without approval of the
- Engineer-in-Charge /construction agency may identify the probable impediments in the execution of projects well in advance and may project contingent measures /plans as identified to deal with them, so as to ensure completion of the projects as per approved time schedule.
- It will be ensured that all the payments to contractors are made through electronic fund transfer only.
- The Engineer-in-Charge will ensure that after A/A & E/S of Preliminary Estimate cum Detailed Estimate, the details like name of work, length, starting and ending point, estimated cost, awarded cost, work completion cost, work start date, completion date, name of agency along with a copy of estimate must be uploaded on the website of the department. Further a small plaque be set up on road site, mentioning agency, date and cost of completion and length of road.
- 10. No deviation in sanctioned cost beyond permissible limit i.e 10% of sanctioned cost shall be
- 11. Tenders shall be invited by way of e-tendering and wide publicity may also be given as per GFR
- 12. The sanction for each of the proposal shall not be sub divided for tender purpose.

The expenditure involved is debitable to Major Head 5054 04 101 Road & Bridges (Minor Head) Sub-Head 94 00 53 from and within sanctioned budget allotment for financial year 2018-19 subjected to availability of funds and compliance of codal formalities.
