Subject: Works to be financed from Central Road Fund administrative approval of one work amounting to Rs.42.21 crore for "Construction of bridge on Supplementary drain on NH-10, Nangloi, Delhi to cover complete width of 60 m with road improvement in 100 m length on either side of bridge including making of drainage scheme, footpath etc. (after dismantling the existing bridge) during financial Year 2018-19 in the NCT of Delhi.

Sir,

I am directed to refer to Government of NCT of Delhi letter No. 54(107)/EE/PWD/F-14/13411-14, dated 04.10.2018 received from Public Works Department, Government of NCT of Delhi forwarding therewith estimate amounting to Rs. 42.21 crore for the work cited above. The administrative approval of the Government of India to the above mentioned work with total estimated cost of Rs. 42.21 Crore (Forty two Crore and Twenty One lakh only) is hereby conveyed subject to following provisions of Central Road Fund (State Roads) Rules, 2007:-

- (i) State Government shall accord technical and financial sanction of the above project within a period of four months from the date of administrative approval of the works failing which the works shall be deemed to have been disapproved unless revised administrative approval of the Government of India is obtained.
- (ii) The period of the completion of the projects is not to exceed 24 months including period for tendering. In any case this time schedule is to be strictly complied with.
- (iii) No excess cost beyond 10% shall be permissible and the excess, if any, over and above 10%, shall have to be arranged by State PWD from their own resources. No revised estimate will be considered in this scheme.
- (iv) The standards, design and specifications of the works shall follow the relevant IRTCZ/ MoRT&H guidelines codes and specifications which may be taken care of at the state of technical sanction.
- (v) No agency, charges will be payable for the execution of the works under the scheme.

(vi) The State Government has to submit Quarterly Progress Reports of the above works sanctioned in Form II & III enclosed with Central Road Fund (State Roads) Rules, 2007 effective from 10th July, 2007. The progress report should reach this Ministry not later than one month from the date of ending of each quarter.

(vii) The display boards on development activities of the work shall be made as per guidelines issued vide Ministry's letter no. RW/NH-33044/10/2002-S&R (R) dated 26th May, 2003.

(viii) The approval of the instant proposal is subject to the condition that State Govt. of Rajasthan shall incur expenditure on their own to avoid delay in execution of the project and the reimbursement/ release of the same shall be against the annual accrual due to the State. Under no circumstances shall the accrual be revised on account of the instant approval.

2. The estimate for above work includes provisions for contingencies at the rate of 3%, quality control at the rate of 1% and work charged establishment at the rate of 1.5% subject to the condition that out of these provisions funds to the extent of 3% of the cost of the work shall be placed at the disposal of the Regional Officer of this Ministry appointed by the Central Government or any other officer authorized for the State or Union Territory for incurring expenditure on hiring manpower and execution of quality control of the works.

3. The State Government shall adopt the e-tendering system on mandatory basis for execution of above works failing which the expenditure incurred on the work will not be reimbursed by the Ministry.


4. The State Government will be required to furnish the utilization certificate in Form I enclosed with the Central Road Fund (State Roads) Rules, 2007 duly verified by the Regional Officer of this Ministry. Further installments of funds will be released to the extent of expenditure incurred and physical progress of the works.

5. The State Government shall furnish completion certificate duly vetted by Audit after completion of work. Maintenance and upkeep of the projects after completion will be the responsibility of the State Government of Rajasthan.

6. At the end of each year, the State Government should furnish a work-wise certificate by 30th April, every year regarding utilization of amount allocated from Central Road Fund for the work under scheme.

7. The expenditure is debitible under the Major Head "3601" Grants in Aid to State Govt. 08-Grant for State Plan Schemes (Sub Major Head) : 08.108-Grant from Central Road Fund (Minor Head) 01.00.35 Grants for creation of Capital Assets under the Demand No. 81- Ministry of Road Transport & Highways for the year 2018-19.
