

 - Monthly physical and financial progress report 1st week of the following month positively.
 - Copy of duly verified and passed bills.
 - Certificate about completion of work.

5. The payment will be release for the said work after the receipt of acceptance letter from PWD to this administrative approval along with the tender copy, work order copy and request for release of funds. The balance amount if any will be released on submission of bill/Revised Estimates duly verified and certified by the competent authority of PWD and also getting a satisfactory completion report from FSL.
6. The work should be tendered after observing due process within 30 days from the date of this administrative order. The penalty clause for delay of the as per rule should be incorporated in the tender and implemented.
7. Officers of FSL would be free to undertake checking and bring to notice of PWD/Contractor the deficiency if any, prompt steps taken to rectify such deficiency as and when pointed out.

The expenditure will be debitable to the "MH 405500212900042" Delhi Forensic Science Laboratory under Demand No. 11 for the current financial year 2018-19.
