Minutes of Meeting

A meeting was held on 27.12.2018 at 4.00 PM in the Conference Room of Engineer-in-Chief, PWD under chairmanship of Engineer-in-Chief, PWD to discuss and deliberate the issues regarding construction of temporary/porta cabin structures for 150 additional court rooms at ground and terrace in the existing court complexes of Tis Hazari, Rohini, Dwarka, Saket and Karkardooma. The meeting was attended by the following:-

The following issues were discussed and decided:

1. Karkardooma Court -

The roof plans along with services given by Executive Engineer, Karkardooma Court to Sh. Irfan Haider, Assistant Architect. It is difficult to construct courts at terrace. Sh. B.B. Yadav, AE, Karkardooma Court suggested to construct courts at ground level by shifting diesel tank and DG set. Sh. Irfan Haider, Assistant Architect, PWD will visit the proposed site and prepare drawings of the proposed courts at ground.

2. Saket Court -

The roof plans along with services given by Executive Engineer, Karkardooma Court to Sh. Irfan Haider, Assistant Architect. Sh. Irfan Haider, Assistant Architect, PWD shall prepare drawings of the proposed courts at terrace.

3. Dwarka Court -

The Executive Engineer, South West Building provided plans and services drawings. The Executive Engineer, South West Building will explore possibility of construction of courts within the existing court complex as suggested by Engineer-in-Chief, PWD. Sh. Irfan Haider, Assistant Architect, PWD will also assist for the same.

4. Rohini Court -

The roof plans along with services provided by Executive Engineer, North West Building to Sh. Irfan Haider, Assistant Architect, PWD. It is not feasible to construct proposed courts at terrace. The alternate location at ground presently being used as coffee house can be proposed for construction of courts. Executive Engineer, North West Building and Sh. Irfan Haider, Assistant Architect will explore feasibility for the same.

5. Tis Hazari Court -

The Executive Engineer, Tis Hazari and Vidhan Sabha Building discussed the proposed drawings for construction of courts at ground with District and Session Judge, Tis Hazare Court prepared by Sh. Irfan Haider, Assistant Architect. It was decided that Sh. Irfan Haider, Assistant Architect will also explore possibility to propose construction of courts at sites which are recently vacated by J&K Transport.
