SANCTION ORDER

With reference to approval of EFC in its meeting held on 12.12.2018 & Cabinet decision 24.12.2018 regarding supply, installation, testing and commissioning of CCTV surveillance system including Comprehensive Maintenance at Tihar, Rohini and Mandoli Prison Complex amounting to Rs.119.69 crore for the year 2018-19 to 2023-24. I am directed to convey the Administrative approval of Rs.119.69 crore (Rupees one hundred nineteen crores) and Expenditure sanction of Rs.25 crores (Rupees twenty five crores) (Ist Installment) of the Competent Authority during the current financial year 2018-19 under demand No.11 for the above said project in pursuance of Dy. Secretary (Home) Department vide No.F.9/64/2015/HG/286-294 dated 22.1.2019 with the following conditions:-

- (i) Project shall be completed as per approved scope of work and the sanction cost within the stipulated period and no cost escalation will be considered in future.
 - (ii) The tender shall be invited as per the approved cost considered on the recommendation of the department.
 - (iii) PWD will make the sufficient budgetary provision in annual budget as phasing down in FRs and CPWD manuals.
 - (iv) The executing agency will observed due economy and all codal formalities laid down in FRs and CPWD manuals.
 - (v) PWD will ensure strict timeline for the completion of the project within the specific time period.
 - (vi) PWD will make penalty clauses in the contract agreement for delay and defects in execution of the project.
 - (vii) The status/completion report will be maintained by PWD & submitted periodically to Delhi Prison/Planning & Finance Department.
 - (viii) All codal formalities as per GFR-2017 and instructions/guidelines issued by the Finance Department and CVC from time to time must be observed by the PWD while executing the work.
 - (ix) Guidelines issued by NGT and other civic agencies from time to time must be followed by PWD while executing the work.
- Remaining sanctions will be issued in subsequent years as per demand given by the PWD department.

The sanction has been accorded in exercise of the powers delegated by the Finance Department, Govt. of NCT of Delhi and in consultation of Accounts functionaries of the department. The expenditure involved on this account would be debitable to the under mentioned Head of Account for the financial year 2018-19 under Demand NO.11.
