Subject: Government Servant to refrain from sharing any information/ statement/opinion to the Press/ Social Media.

In view of some News Articles published in News Paper regarding new construction proposal/ongoing PWD works/projects, wherein PWD officers are quoted anonymously to have shared the information with the media.

In this regard, kind attention is invited towards CCS (Conduct) Rules- 1964, wherein it is clearly stated that no Government Servant shall, in his own name or anonymously, pseudonymously or in the name of any other person, in any electronic media or print media or in any communication to the press or on television, social media, social networking sites like Twitter/ facebook or on Social networking groups like WhatsApp, or in any public utterance, make any statement of fact or opinion without prior approval of the competent authority of the Central Govt. or a State Govt.

In view of the above, all the concerned are advised to strictly refrain from sharing any information/ opinion/ views in any form with the media, which may tantamount to violate CCS(Conduct) Rules 1964 and attract any disciplinary action.

This issues with the approval of E-in-C, PWD, GNCTD.
