विषयः Proactive approach in disposing off First Appeal under RTI Act 2005.

Hon'ble Central Information Commission, New Delhi while deciding second Appeal No.CIC/PWDDL/A/2019/121121 of Sh.Bishamber Nath (Applicant) V/s PIOs , PWD GNCTD New Delhi has noted that unfortunately, the matter could have been resolved at the stage of the First Appeal, had the First Appellate Authority made an endeavor to adjudicate the case. However, complete inaction on the part of the FAA has resulted in not only jeopardizing the RTI regime by defeating the very purpose of the dissemination of information, but the delay in providing relief also reflects the failure of the respondent organization in taking necessary steps for its retired employees.

The Commission has recommended that appropriate steps should be taken to sensitise the FAAs and make them more proactive to address issues involving the public within reasonable time in future. This lapse on the part of FAAs has been viewed very seriously by Engineer-in-Chief, PWD, Delhi. All FAA's are here by advised to make sincere efforts while disposing off First Appeal and to take proactive action to address issues involving the public within reasonable time in future.
