Sir/Madam,

Kindly refer to this office letter mentioned above, whereby your kind office was informed of the letter dated 25.09.2018 of Additional Director General NCC (Delhi) vide which it was informed that NCC is the largest Uniformed Youth Organization in the world and is rendering a great service to the Nation. Cadets devote considerable time in pursuing NCC related training activities and contributing their valuable time due to which the academics get affected. He has accordingly recommended for a uniform Code of Incentives for cadets, and that facility as extended by other states be extended by Delhi Government to its NCC Cadets.

A Copy of letter dated 03.01.2019 of ADG, NCC was also attached with the above referred letter as Annexure-II wherein the incentives have been divided into three categories, that is: Academic, Employment and Cash Incentives, as indicated in para 5 of the letter. The Academic incentives are to be provided in Colleges/ Professional/ Vocational Institutions.

The recommendations relating to employment provide for weight age for selection in various jobs under State Government, that is Police Force, Home Guard, Forest & Environment, Fire & Rescue, Health & Hygiene, Public Works Department, other State Government Jobs, as indicated in Para 6 of the letter dated 03.01.2019.

It is once again requested to kindly get the recommendation examined and furnish your views to enable the Directorate to put up appropriate proposal before Competent Authority.
