**C I R C U L A R**

Sub: Reservation for Economically Weaker Sections (EWSs) in direct recruitment in civil posts and services in the Government of National Capital Territory of Delhi.

Time and again, the Departments/Autonomous Bodies, Corporations, boards and PSUs of Govt. of NCT of Delhi have been advised to fill up all the vacancies pertaining to direct recruitment quota under their respective control by sending requisitions to the respective recruiting agencies.

Services Department, vide Circular No.F.19(10)/2018/S-IV/1595 dated 28.05.2019, has endorsed the DOPT's OM dated 31.01.2019 on reservation for EWSs in direct recruitment in civil posts and services in the Government of NCT of Delhi, as per the modalities prescribed therein.

All HODs are hereby advised to also duly include the posts reserved for EWS in the vacancies against direct recruitment quota while sending requisitions to the respective recruiting agencies.

The DSSSB, in order to comply with the above referred DOPT's OM dated 31.01.2019, has sent back the vacancy requisitions to the respective departments with the request that reservation roster may be revised in accordance with the DoP&T's OM dated 31.01.2019, endorsed by Services Department vide Circular dated 28.05.2019, and submit the revised vacancy position for further notification.

Accordingly, all HODs are advised that the requisitions already sent without earmarking the vacancies for EWS may be appropriately revised, wherever required, and revised requisition be sent to DSSSB at the earliest to enable the Board to notify the vacancies.
