Madam/Sir,

I am directed to inform you that as per existing policy, revision of Electoral Rolls with reference to 01st January of the coming year as the qualifying date is done in later part of each year. Accordingly, Election Commission of India has directed to conduct Special Summary Revision of electoral rolls w.r.t. 01.01.2022 as qualifying date, in NCT of Delhi as per schedule given below:

1.	Publication of Integrated Draft Electoral Roll at all polling station locations	01.11.2021
2.	Period of filing claims and objections	01.11.2021 to 30.11.2021
3.	Special Camps at all polling station locations	06.11.2021 (Saturday) & 07.11.2021 (Sunday) 27.11.2021 (Saturday) & 28.11.2021 (Sunday)
4.	Final Publication of Electoral Roll	05.01.2022

During the period of filing claims and objections i.e. 01.11.2021 to 30.11.2021, any eligible person including those who will be completing 18 years of age on 01.01.2022 can apply for inclusion of their name in the electoral roll in NCT of Delhi. The application for inclusion in electoral roll may be made in Form-6, deletion of an existing entry from the electoral roll in Form-7, correction in existing entry in Form-8 and change of address within same Assembly Constituency in Form-8A. All these Forms can be downloaded from the website of this department www.ceodelhi.gov.in. Further, the application in concerned Form may also be made online at <https://nvsp.in> or <https://voterportal.eci.gov.in>.
