However before incurring any expenditure, Engineer-in-Charge must ensure that all requisite codal formalities as per GFR-2005, CPWD Works Manual, instruction of Finance Department, GNCTD, GOI and CVC guidelines have been observed.
- 2. A/A & E/S has been accorded purely based on the estimated calculation submitted by the Executive Engineer, North Roads Division (M-313). However, the detailed requirement such as quantity, rates and its technical specification, feasibility, necessity etc. for each component shall be worked out by the Executive Engineer, North Road Division at the stage of preparing detailed estimate/ technical sanction/NIT/Justification etc.

The sanction for each of the proposal shall not be sub divided for tender purpose.
