6. The completion certificate with endorsement of the in charge Deputy Director/ DAHO concern shall be furnished on completion of the job.
7. That the expenditure incurred/ to be should not exceed the allocation of funds and the restricted to the total budget available in the current financial year 2021-22, in the Major Head 4403 00 101 90 00 53 (Major Works)
8. The guidelines given by CVC and Govt. of Delhi time to time should be complied.
9. Escalation of cost will not be allowed.
10. The expenditure involved on the account will be debitible to M.H. 4403 00 101 90 00 53 (Major works) Veterinary Services and Control of Contagious Diseases in Hospital and Dispensaries Capital Plan in the expenditure demand no. 10 of Govt. of Delhi for the year 2021-22 and should not exceed the sanctioned amount placed at your disposal.
