The Ministry of Health & Family Welfare Government of India is implementing the Pradhan Mantri TB Mukh Bharat Abhiyaan (PMTBMBA) under which an exclusive web portal for registration of Ni-kshay Mitra (donors) has been developed who can provide nutritional, diagnostic and vocational support to consented TB Patients for a period from six months to three years. The Ministry vide letter dated 03.10.2022 has requested to involve all serving officers at the State/UT Government and the Officers/Staff Associations to come forward and become Ni-kshay Mitra. 


