ORDER

WHEREAS disciplinary proceedings under Rule 14 of the Certral Civil Services (Classification, Control & Appeal) Rules, 1965 was initiated against Shri Anil Kumar Verma, hereinafter called as Charged Officer (CO), Executive Engineer (Electrical), Central Public Works Department (CPWI), vide Memorandum No.27-EE/V(7)/86-EC-II, dated 22,09,1992 on the following article of charge:

That the said Shri A.K.Verma, EE (Electrical), CPWD while working as Executive Engineer (Electrical) in DDU Project, PWD, New Delhi has been wilfully and unauthorizedly absenting himself from duty after availing of 36 days Earned Leave with effect from 06.12.1990 to 10.12.1990 and 12.12.1990 to 11.01.1991 granted by the Project Manager, DDU Hospital Project, New Delhi vide O.M. No.15 (114)/90-DDUHP/16 dated 02.01.1991, thereby contravening the provisions of Sub Rules (i) (ii) and (iii) of Rule (i) or file Central Civil Services (Conduct) Rules, 1964.

- 2. AND WHEREAS consequent upon non-submission of written state nent of defence by the CO, the Disciplinary Authority (DA) remitted the case for oral inquiry and Shri Chandra Pal, ADG (Rtd.) and Shri R.P. Meena, DD (Adir II) were appointed as Inquiry Officer (IO) and Presenting Officer (PO) respectively to inquire into the charge tramed against Shri A.K. Verma, EE(E) vide Order dated 03.10.2006.
- 3. AND WHEREAS the IO conducted the inquiry ex-parte because the CO neither represented/responded to the communications issued to him by the IO nor appeared in the Inquiry conducted by the IO.
- 4. AND WHEREAS the IO submitted the inquiry report vide his letter dated 02.07.2007 and held the charge framed against the CO "as proved".
- AND WHEREAS on examination of the inquiry report it was observed that there are sufficient documentary evidences to prove the charge framed against the CO.

AND WHEREAS consequent upon acceptance of 10's report by the Disciplinary Authority, as per Rule 15(2) of the CCs (CCA)Rules, 1765, the 10's report was forwarded to the CO vide OM No.27-EE/V(7)/86-EC-II (PI I/EW-I clated 20.08.2007 for making representation, it any, against the findings of the Inquiry Officer within 15 days of issue of the O.M.
- 7. AND WHEREAS the Charged Officer had not made any submission against the inquiry report.
- 8. AND WHEREAS the case was referred to UPSC for their advice in the matter. UPSC in turn vide their letter No.3/438/2014-S.I, dated 20.04.2015 tendered their advice, inter alia, observing that after taking into account all other aspects relevant to the case, the Commission consider that the ends of justice would be met in this case if the penalty of "dismissal from se vice" which shall ordinarily be a bar for future employment under the Good, service is imposed on the CO, Shri A.K. Verma.
- 9. AND WHEREAS in accordance with the DOP&T's O.M. No.11012/8/2011-Estt. (A), dated 19.11.2014, a copy of the UPSC advice was forwarded to the CO vide DG, CPWD, Memorandum dated 23.04.2015 to enable him to make representation against the advice of the UPSC, if any, but the CO did not submit any representation in this regard.
- 10. NOW, THERFORE, after careful consideration of the case in its entirety, the President being the disciplinary authority has decided to accept the advice of the UPSC and to impose the penalty of "dismissal from service" which shall ordinarily be a bar for future employment under the Govt. service in terms of Rule 11 (ix) of CCS (CCA) Rules, 1965 on the CO, Shri A.K. Verma, LE (F), C "WD with immediate effect and orders accordingly.
