Sir,

I am directed to refer to the MHA's letters of even No.23014/241/2012-VS, dated 15.04.2024 and 17.04.2024, on the subject cited above. The commission, keeping in view the overriding security considerations, had permitted the use of Government/PSU aircraft/helicopters by the Prime Minister during his election tours vide letters no.437/6/96-PLN-III dated 09.04.1996 and letter no. 437/6/98/PLN-III dated 08.01.1998. The Commission had further permitted Prime Minister to combine official visit with election related visits vide letter no. 437/6/CG/2014-CC&BE dated 07.10.2014. The Commission had also directed that the construction of helipads during the visit of the Prime Minister may be done by the State/UT administrations vide letter no. 437/6/MISC/2015-CC dated 19.06.2015 as mandated by the security norms.

In view of the serious security concerns, as indicated by MHA in the above referred letters, and specific and mandatory security norms as specified in "Rules and Instructions for the Protection of Prime Minister" also called the Blue Book, and to remove ambiguity in providing prescribed comprehensive security cover, it is further clarified that on receiving information about schedule of the Prime Minister's visit, the concerned State/UT administration is permitted during MCC period to undertake construction of helipads, rostrums for public meetings and barricading on the ground and during road shows as per security specifications in the Blue Book, and instructions issued by concerned security related authorities from time to time. The State governments are allowed to incur expenditure on the construction of such helipads, rostrums and barricades and then seek reimbursement from the Central Government.
