The counting of votes was cancelled for re-polling vide notice No. CPWDEA/Election/2024-26/141 Dated 04.10.2024.

The schedule of re-polling is as per details given below :

- 1 Date & time of Re-Polling : 24.10.2024 between 11 a.m. to 5 p.m. at Association Office, I.P. Bhawan, ITO, New Delhi – 110002.
- 2 Counting of Votes & declaration of result : 25/10/2024 from 11 a.m. onward

NOTES:-

1. Members who have paid their Annual Membership Subscription up to the year 2024-25, are eligible to vote in the election. (as per clause 32.04.6 of bye-laws)
2. Every member shall cast one vote for each post and voting shall be through secret ballots.
3. Members, who can attend voting at New Delhi, can cast their votes at Central venue at Association office. The other outside members (other than posted at Delhi/NCR) who can't cast their votes in Delhi, shall be entitled to vote by Postal Ballot, which will be sent by Speed Post/Courier on or before 17.10.2024 by the Election Officer, through concerned Region/Zone/Branch/Unit etc. The same are to be returned back to the Election Officer by Speed Post/Courier up to 5.00 p.m. on **24/10/2024**.
4. Members posted outside the Region/Zone/Branch/Unit Headquarters are requested to contact their respective Region/Zone/Branch/Unit Office for further details& guidance.
5. Postal Ballots are to be sent by Speed Post/Courier well in time. No complaints will be entertained regarding Non-receipt of Ballot due to postal delay.
6. For any kind of disputes arising in the process of election, decision of the Election Officer shall be final and binding for all. (ref Clause No. 32.04.5)


