With reference to PWD office letter No.F.27(40)/CE/PWD/2024/5784(H) dated 11.12.2024, earlier letter No. 10(110)/PWD-I/Vig.Clr/2024/6558 dated 14.08.2024 and in supersession of Vigilance status conveyed by DOV, vide letter No. 99/7/2024/DOV/12505 dated 22.11.2024 on the subject cited above, I am directed to convey the revised Vigilance status in respect of the officer, as under, which is as per records of DOV and the same may be interpreted by the HOD/Competent Authority in the light of DOPT/GOI's OM. Makhan Lal Meena, AE(Civil) was charge sheeted u/r 14 of CCS (CCA) Rules, 1965, vide OM No.10/V-23/(A-138)/2017-VS.I dated 23.12.2020.  A decision has been taken by DG, CPWD, GoI, Vigilance Unit vide letter No. 1/7/D-II/2021-VS.II dated 31.05.2023 was imposed the penalty of "reduction to a lower stage in the time scale of pay by two (2) stages for a period of one (1) year with further direction that he will earn increment of pay during the period of such reduction and, on the expiry of such period, the reduction will not have the effect of postponing the future increment of pay" upon Sh. Makhan Lal Meena, AE(Civil), CPWD.  The penalty period has now been completed on dated 31.05.2024 & restoration order issued vide SE(M), PWD letter No.8(2)E-I/ South East(M)/PWD /2024-25/1405 dated 12.06.2024.


