

Terms of References of the committee shall be as under:-

1. Analyze the existing workload of all Circles/Divisions & Sub-Divisions viz-a-viz existing sanctioned posts and suggest restructuring/rationalization of posts in PWD, GNCTD to optimize manpower utilization.
2. As per analysis of workload on all Circles/Divisions & Sub-Divisions viz-a-viz existing sanctioned posts, the committee shall give its recommendation for
  - (i) Transfer of under-utilized posts or posts having less workload to other division/sub-division.
  - (ii) Closure/Creation of new division.
  - (iii) Structural changes required, if any.

The committee shall submit the relevant report within 20 days of the constitution of Committee.
