

CIRCULAR

Sub: Communication outside PWD, GNCTD, by the Engineering Wing (PWD).

1. In partial modification of Circular No. F.4(60)/2023-24/PWD-II/Roads/dspwd-2/613-623 dated 29th May, 2023 on the above noted subject, it has now been decided that the estimate for the works of the Client Departments which are to be carried out from the Budget Head other than Demand no.11, shall be sent directly to the Client Department by the concerned Engineering Wing of PWD for issuance of necessary A/A & E/S.
2. However, while forwarding the Estimate, a Budget Head as considered relevant, shall also be proposed under which the Client Department is expected to issue A/A & E/S. Also, before calling any tender for carrying-out the proposed work, the concerned Engineering Wing (PWD) shall also ensure the availability of funds in the respective Head of Account under which A/A & E/S has been issued by the Client Department.
3. Further, in all cases where the work of the Client Department has to be carried out from the Budget Head of Demand no.11, the approval for forwarding of Estimate shall be obtained from the PWD Secretariat by forwarding the requisite information as in the attached format.


