

6. As per DDG, ERP, CPWD OM no. DDG (ERP)/Trg./2023/110 dated 17/03/2023, the relieving and joining of transferred officers shall mandatorily be issued through ERP Transfer Posting Module in e-NIRMIT only.
7. TTA and Joining Time shall be admissible as per rules unless otherwise mentioned in individual cases / specific officers.
