OFFICE ORDER

Name of Work :- A/R & M/O various roads under Division WR-1, New Delhi during 2024-25. (SH : Providing services of maintenance vehicles for regular use with required labour and T&P for Sub Division WR-13).

Agreement No. 02/ई.ई./ लो.नि.वि./ मं. पश्चिम रोड-1/दि.स./2024-25

Stipulated date of start:- 15.06.2024

Stipulated date of completion:- 14.06.2025

1. Whereas the work of " A/R & M/O various roads under Division WR-1, New Delhi during 2024-25. (SH : Providing services of maintenance vehicles for regular use with required labour and T&P for Sub Division WR-13)." was awarded to you and agreement No. 02/ई.ई./ लो.नि.वि./ मं. पश्चिम रोड-1/दि.स./2024-25 was drawn.
2. Whereas, the stipulated date of start and completion of subject work was 15.06.2024 and 14.06.2025.
3. Whereas, it was complained by Executive Engineer, West Road -1 that " M/s Work Cee " have been involved himself in physical abuse in the office campus of Assistant Engineer West Road-13. The case was also intimated at police station as per letter no. 54(Works)/AE/WR-13/PWD/13 dated 22.01.2025 and letter no. 54(DB)/PWD/WR-1/2024-25/141 dated 22.01.2025. You have violated the condition of contract and Rules of enlistment of contractors in CPWD. :
 - (i) This is pertinent to mention that you are a non-enlisted contractor of CPWD but you are listed in clause-3 (B&R) of Delhi Development Authority, New Delhi. As you are a working contractor of PWD and enlisted also in another department, hence basic rules for enlistment should be known to you and you are supposed to abide by these rules. It will never be accepted physical manhandling or involvement in physical abuse in office with government employees.
 - (ii) It is clearly mentioned in enlistment rule of contractor Para 13.6 (t) that contractors may be debarred on the grounds "Misbehaviour, direct or indirect involvement in threatening, making false complaints, filing legal suites for frivolous reasons, or any behavioural act, omission of commission damaging the reputation of department/officers."


- (iii) On scrutinizing the complaint submitted by Executive Engineer, West Road-1 and reply submitted by you, it is clear and established that you were involved in physical abuse in office, threatening, making false complaints against officers, damaging the reputation of department/officers which are not at all acceptable.
4. Whereas, you have failed to abide the rules prescribed for contractors including not executing the work satisfactorily as per enlistment rules and you have also violated the conditions of contract.
5. Whereas, as per Rule 13.6 of Rules for Enlistment of Contractors in CPWD 2023, the contractor may be debarred, if it is established that:
- (i) "Fails to execute a contract or executes it unsatisfactorily".
(ii) "Violates any conditions of the contract".
6. Whereas, by failing to execute the contract satisfactorily and violating the conditions of contract as intimated by the Engineer-in-Charge, you have made yourself liable for action for debarment as per Rule 13.6 of Rules for Enlistment of Contractors in CPWD 2023.
7. Whereas, a show notice was issued to you i.e. " M/s Work Cee " vide letter No. 23(164)/पश्चिम परिमंडल एम/2025-26/3313 dated 28.07.2025 to show cause within 07 days of the issue of notice as to why disciplinary action should not be taken against you under Rule 13 of the Enlistment Rules -2023.
8. Whereas the reply was submitted by "M/s Work Cee" vide letter No. Nil dated 03.08.2025 along with supporting documents and Annexures.
9. Whereas, as per order issued by Engineer in Chief, PWD, GNCTD vide letter No. E-in-C/PWD/Works/OO/2022/1841 dated 23.05.2022 as below:
As per para 13.6 and OM-DG/SE/CM/ENLISTMENT RULES/60 dated 29.11.2021. (Copies of relevant pages enclosed) the enlistment of contractor/agency may be cancelled if contractor/agency has faulted on any one of the issues mentioned in above said para. Some of common faults are reproduced as below:
If, agency fails to executed a contract or executes or executed it unsatisfactorily.
or
Violates any conditions of the contract.
or
Fails to abide by the conditions of enlistment.
or
Does not start the works after same is awarded to him on two occasions.
10. Whereas, by failing to abide by the terms and conditions of the NIT/Contract/Agreement and Enlistment Rules of department, M/s Work Cee have made themselves liable for action for debarment as per Rule 13.6 of "Rules for Enlistment of Contractors in CPWD 2023 (amended time to time)".



11. After carefully considering your reply of show cause notice, taking into consideration of all the facts placed on record, circumstances of the case, the Competent Authority found that action against M/s Work Cee is justified in above mentioned rules and exercising the powers conferred upon Rule 13 of "Rules of ER in CPWD 2023" hereby debar "M/s Work Cee" for a period of one year from the date of issue of this order. The debarment would entail following:-

- i Ban on participation in the tendering process in CPWD and PWD (Delhi)
- ii. Award of contract for works in CPWD and PWD (Delhi).
- iii. However, running contracts shall remain unaffected.

This is issued with approval of competent authority i.e. Chief Engineer (North), PWD, Delhi.
