**MINUTES OF THE MEETING**

In pursuance of the Order No. F.No. 11/32/2025/Home-II/497-500 dated 20.03.2025, the 6<sup>th</sup> Meeting of the Sub-Committee was held under the Chairmanship of undersigned on 24.07.2025 at 12:00 hrs. with the officials comprising from traffic police and PWD to discuss the various issues related to traffic congestion and dark spots in Delhi. The following officers attended the meeting: -

- i) Sh. Shailendra Mishra, Chief Engineer/PWD
- ii) Ms. Monika Bhardwaj, Addl. CP/T (Zone-I)
- iii) Sh. Dinesh Kumar Gupta, Addl. CP/T (Zone-II)
- iv) Sh. S.K. Singh, DCP/T (HQ-II)

At the outset, Chairman of the Sub-committee welcomed all the officers / participants in his meeting and asked for the updates regarding the previous meeting.

Following is the gist of the decisions / directions taken during the meeting: -

1. The Chairman sought an update on the letter addressed by the Worthy Commissioner of Police, Delhi, to the Chief Secretary, GNCT of Delhi, regarding the 233 engineering interventions identified/required for improving road infrastructure and enhancing the safety of road users. The Chief Engineer, PWD informed that approximately 91 tasks pertaining to PWD have already been completed, while some other works, though executed on the ground, are yet to be formally recorded. The remaining tasks will be taken up on priority.

*(Action: PWD and other civic agencies to expedite implementation and provide updated status reports. Addl. CP/Traffic (Zone-I & II) to monitor and pursue the matter with the respective agencies.)*

2. Addl. CP/Traffic (Zone-II) apprised and handed over the list of pending interventions in his jurisdiction and requested that priority be given to works that can be executed promptly, such as road markings and installation of signboards. In response, PWD officials assured that necessary directions would be issued shortly for executing road markings and signboard installations at the identified locations.

*(Action: PWD to undertake short-term interventions on a priority basis.)*

3. Addl. CP/Traffic (Zone-II) expressed concern that neither MCD nor DTC has completed any of the assigned tasks in his jurisdiction. He requested

that officials from these agencies must attend future meetings to facilitate timely resolution.

*(Action: A letter shall be written to MCD/DTC etc. to attend the next meeting.)*

4. Regarding the 12 critical corridors identified for urgent engineering interventions, Addl. CP/Traffic (Zone-II) informed that joint inspections have been conducted and the report would be submitted after re-examining the survey.

*(Action: Addl. CP/Traffic (Zone-I & II) to finalize and submit joint inspection report; PWD to Initiate necessary engineering interventions based on the report.)*

5. The Chief Engineer, PWD, informed that approximately 500 potholes have been filled since the last meeting. Only about 10% remain, which will be addressed shortly.

*(Action: PWD to Complete remaining pothole repair works at the earliest.)*

6. DCP/Traffic-HQ-II requested PWD officials to carry out zebra crossing markings at locations where RLVD cameras are installed, highlighting that the absence of such markings is hindering effective enforcement and issuance of challans. In response, the Chief Engineer, PWD, informed that road markings are undertaken annually in the run-up to Independence Day and requested that the list of RLVD camera locations be shared with PWD to facilitate timely action.

*(Action: DCP/T-(HQ-II) to Share the list of RLVD camera locations; PWD to Undertake zebra crossing markings at the identified locations on priority.)*

7. Addl. CP/Traffic (Zone-II) emphasized urgent completion of the Dasghara-Inderpuri road. PWD officials said DJB clearance is awaited. DCP/Traffic-HQ-II informed that water pipeline work is underway and requested coordination for early clearance.

*(Action: PWD to Coordinate with DJB for clearance; DJB – Confirm status of pipeline work.)*

8. Jt. CP/Traffic (Ops) requested that the feasibility of constructing a Foot Over Bridge (FOB) at Mahipalpur be explored, citing multiple complaints regarding pedestrian movement. In response, Addl. CP/Traffic (Zone-II) stated that the location currently does not appear feasible; however, a joint field survey will be conducted with PWD to assess its viability.

*(Action: PWD & Addl. CP/Traffic (Zone-II) to conduct joint survey to examine feasibility of FOB at Mahipalpur and submit findings.)*

9. Addl. CP/Traffic (Zone-I) reported improvement in waterlogging but flagged new points near Jahangir Puri Metro Station, Munirka Bus Stop,



and Tis Hazari (Rani Jhansi Road). The Chief Engineer, PWD, assured that the matter would be examined and acted upon.

*(Action: PWD to investigate and implement remedial measures at new waterlogging sites.)*

10. Addl. CP/Traffic (Zone-II) acknowledged improved waterlogging response time but stressed the need for better monitoring of mobile pump vans. DCP/Traffic-HQ-II echoed the concern and requested immediate action.

*(Action: PWD to Improve monitoring and timely deployment of mobile pump vans.)*

11. Jt. CP/Traffic (Ops) requested an update on the installation of signages. The Chief Engineer, PWD, assured that the update would be provided within 10 days.

*(Action: PWD to Share signage installation status within the committed timeline.)*

The meeting ended with the vote of thanks to all the participants.
