Subject: Compliance with Provisions under Clause-6, Para 8 & 9 of GCC Maintenance Works 2023 - Regarding.

Reference is invited to the circular issued by the Director General, CPWD vide No. 1. DG/CON-Maintenance-2020/338 dated 13.04.2023, which has been incorporated in the GCC Maintenance Works-2023. Relevant extract is reproduced below:

"If the contractor fails to submit the CMB /CLB / EMB along with abstract of measurements for the work done continuously for two months, then the Engineer-incharge shall get the executed work measured ex-parte after giving a notice of seven working days to the contractor in writing either through site order book or any other mode of correspondence. The ex-parte measurements so undertaken by the Engineerin-Charge shall be final and binding on the Contractor and shall be outside the purview of Clause 25 of this GCC.

Resources deployed by the Engineer-in-charge for ex-parte measurements, subject to minimum of Rs 7500.00 per such two-monthly cycle of ex-parte measurement, shall be at the risk and cost of the contractor and shall be recovered from his bill. A copy of such ex-parte measurements shall be sent to the contractor for his record."

- It is requested that a certificate of adherence to the above provisions, as per the format enclosed herewith be furnished to this office within 15-days from the date of issue of this Memorandum.
