- 4. **Duties and Responsibilities:** The Consultant shall perform duties as assigned by the Addl. Chief Secretary, PWD/Competent Authority.
- 5. **Termination:** The engagement is of a temporary nature and the engagement can be cancelled at any time by the department/autonomous body / PSU / grant-in-aid institution concerned without assigning any reason;
- 6. Other Conditions: The Consultant shall be governed by all the terms and conditions laid down in the OM No. F.20/4/2015-AC dated 04.12.2015 issued by Finance (Accounts) Department, Govt. of NCT of Delhi and provisions & guidelines issued by the Government of NCT of Delhi from time to time regarding engagement of consultants.
