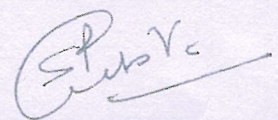
OFFICE ORDER

Sub: Engagement of Sh. Asok Kumar G, IAS (Retd.) as Consultant in Public Works Department, Government of NCT of Delhi.

Approval of Hon'ble Lt. Governor, Delhi is hereby conveyed for engagement of Sh. Asok Kumar G, IAS (Retd.) as Consultant in the Public Works Department, Government of NCT of Delhi, with immediate effect, on the following terms and conditions:

1. **Tenure:** The engagement shall be initially for a period of one year, which may be extended or curtailed as per the requirements of the Department and satisfactory performance.
2. **Remuneration:** The amount of monthly consolidated remuneration/fee in case of retired Govt. Officials appointed as Consultants shall be Last Pay minus Basic Pension Plus DA at the applicable rate. However, a retired Govt. Officer appointed as Consultant shall continue to draw pension and the dearness relief thereon during the period of his engagement as consultant. His/her engagement as consultant shall not be considered as a case of re-employment. The consultant shall not be entitled to any allowances such as HRA, reimbursement of call charges of Residential Telephone/mobile, transport facility, Personal Staff etc.
3. **Nature of Engagement:** The engagement is purely on a contractual/consultancy basis and shall not confer any right for regular appointment in the Government.
4. **Duties and Responsibilities:** The Consultant shall perform duties as assigned by the Addl. Chief Secretary, PWD/Competent Authority.
5. **Termination:** The engagement is of a temporary nature and the engagement can be cancelled at any time by the department/autonomous body / PSU / grant-in-aid institution concerned without assigning any reason;
6. **Other Conditions:** The Consultant shall be governed by all the terms and conditions laid down in the OM No. F.20/4/2015-AC dated 04.12.2015 issued by Finance (Accounts) Department, Govt. of NCT of Delhi and provisions & guidelines issued by the Government of NCT of Delhi from time to time regarding engagement of consultants.

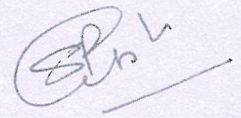
