ORDER

Sub: Re-Constitution of 11 District-wise Cross-Functional Teams for air pollution control during winter season 2023-2024

Keeping in view the approaching winter season and the expected rise in air pollution, there is a need to intensify on-going pollution control and ground-level monitoring efforts. Accordingly, 11 District-wise Cross-Functional Teams are hereby constituted. Each team shall be co-chaired by the respective District Magistrate (Revenue), Deputy Commissioner (MCD), and Deputy Commissioner of Police (Delhi Police), with representatives from DPCC, CPWD, NHAI, Transport Department, PWD, and DOA.

The teams will conduct surprise field visits to check violations regarding open burning, C&D dust, road dust, traffic congestion, parking norms violation, stubble burning, DG sets operation, visibly polluting vehicles, firecrackers control, ban on use of 19 Single Use Plastic etc., as per area jurisdiction.

The structural composition of each of the 11 Cross-Functional Team will be as mentioned below:

1.	District Magistrates (Revenue) Deputy Commissioners (MCD) Deputy Commissioners of Police (Delhi Police)	Co-Chairing
2.	SDM Headquarter (HQ)	Member Secretary
3.	Representative of DPCC	Member
4.	Representative of CPWD	Member
5.	Representative of NHAI	Member
6.	Representative of Transport Department	Member
7.	Representative of PWD	Member
8.	Representative of DOA	Member

The teams can also co-opt any other department representative as per requirement.

SDM (HQ) will act as Member Secretary for convening the meetings and coordinating for other works related to 11 Cross-functional teams. SDM (HQ) to submit compiled action taken report of all 11 cross functional teams to the Department of Environment & Green War Room (greenwarroom2023@gmail.com) on a weekly basis. The team will convene meeting every Monday in alternate offices of the Co-Chair.
