## INSPECTION NOTE OF SHISHIR BANSAL, PROJECT MANAGER F-12

The inspection of the above work was carried out by Shishir Bansal, Project Manager, Flyover Project Circle F-12, on 29.05.2014 at 06:00 PM. Following were present:

During the inspection, following observations are made:

- 1. The shuttering of voided slab of structure 'C' has been started for four span continuous namely RP-26 to RP-30. VT columns along with shuttering plates have been placed in portion for middle two spans but work is other two ends spans is getting delay due to 03 trees which are to be transplanted by the Horticulture Department. The Dy. Director (Horticulture) was called on telephone and has been requested to issue a work order after collecting spot quotation for transplanting these 03 trees on top prority by next day.
- 2. Preparation for making shuttering arrangement and placing the reinforcement for pile cap No. RB-08 was in progress. It is observed that three piles are getting out of the alignment upto 100 mm. Agency has been directed to shift the outer phase of pile cap for these piles to accommodate the shift of the piles. Further, if necessary skin reinforcement may be provided in the shifted portion.
- 3. The starting point of structure B & C is having a hindrance due to underground DTL cables. Partial excavation was done by the agency to assess the exact location of the cables. Agency has been directed to complete the excavation manually in controlled manner so as to avoid any accident due to presence of DTL cables.

The Executive Engineer has been directed to explore the possibility a shutdown for a short duration so that excavation can be done fast and cables be located without causing any risk to the workers.
