INSPECTION NOTE

GBSS Ramjas Lane School, Karol Bagh, New Delhi was inspected by the undersigned on 6.6.2014 along with Shri A.K. Singh, Executive Engineer (M-433), Shri J.P. Yadav (A.E. M-4331), J.E. and contractor / their representatives working there.

The observations are as below:

I.

Name of work: Construction of SPS Type Multipurpose Hall at GBSS School.

- Centering and shuttering for the first floor slab erected, but the fabrication of steel reinforcement for slab not started. In shuttering gaps were visible, these are to be closed before placing of reinforcement and pouring of concrete.
- In the columns, the steel reinforcement has not been fixed as per specifications, as
 joints in the reinforcement have been made at one place instead of staggering of
 the same. Steel reinforcement should be re-fixed as per CPWD specifications, BIS
 456:2000. Few bars lying at site were found to be of secondary producer, this
 should not be allowed on work.
- Steel frame fixed for the canopy/chajja over the steps is found to be of smaller size, this should be extended beyond sizes of the steps to protect users from the rain, sun light etc.
- Ramp should be made so that building may become easily accessible to the person with disability.
- Stipulated date of completion of the work was 5.6.14 but the progress of the work is found to be less than 30%. The contractor have to expedite the progress and work should be completed within least possible time to avoid inconvenience to the user, students as the schools are to be re-opened during first week of July 2014.
- No electrical work was in progress. E.E.(Civil) was directed to pursue the matter with E.E.(Electrical) to take up the electrical work simultaneously.

II.

The work of fire fighting arrangements being carried out at above school was also inspected and following observations made

- Iron Girder, PVC water Tank etc. have been brought at site by the contractor. Directions were given that before placing steel girder, the steel primer is necessarily be
- It was also directed to finish the work up to 27-06-2014 i.e. within stipulated date of completion in all the schools, where the works under this agreement are in progress.

III.

General

The building/campus was inspected and it was informed by the field staff that campus consists of 2 portions.

(i) GBSS Ramjas Lane School maintained by PWD &

(ii) Primary School maintained by MCD.

- On roof it is found that potion maintained by PWD is neat & clean having proper water proofing treatment. Directions were given to rectify the small-small defects pointed out at site and cleaning of roof before monsoon to avoid choking of rain water pipe.
- In building some steel doors and windows were found broken, these are to be repaired/replaced.
- Some small defects in existing surface are visible which are to be set right before A/R & M/O work.

Sh. J.L.Sharma, Principal of the School informed that he is satisfied with the performance of PWD and appreciated efforts made by J.E./A.E./E.E. in maintenance of School building. He insisted and desired that ongoing work should be completed before reopening of the school to mitigate inconvenience to the students and staff.
