**Inspection Note**

The Chief Engineer, PWD, Maintenance Zone M-4 has inspected following roads under M-44, along with Shri M.K. Mallick, Superintending Engineer, M-44 on 19/07/2014. Following observations have been made:-

**1. Savitri Cinema Road.**

- a) Drain from Savitri Cinema to slip road of flyover to be checked for blockage, if any. The same is to be cleared on priority to avoid water logging.
- b) At three points there is local depression where water was observed.
- c) At one place construction materials were stacked on the R.O.W be removed immediately.
- d) At many places, malba was lying on the road and footpath which should be removed immediately.

**2. Bipin Chandra Pal Marg**

- a. The work of drain is to be expedited.
- b. Malba were seen to be lying at places & should be removed on priority.
- c. At many places work of footpath has been left half done. This needs to be completed to avoid inconvenience to the public.
- d. All old electric poles are still standing, these needs to be removed without any delay.
- e. Electric cables for the street light have been placed near surface at kerb channel, this may be set right & be placed at appropriate level.

**3. Kalka Public School Road**

- a. At Municipal Dhalao, lots of malba and construction waste were stacked. This needs to be removed. The matter may be taken up with MCD for Dhalao cleaning.
- b. At places patch work needs to be done.
- c. No further excavation be done.

**4. Road No. 13**

- a. At T-point footpaths and central verge needs to be improved.
- b. Road surface is in shabby position and needs to be improved.
- c. The work of drain completed recently has not been carried out properly & deficiencies should be got rectified on priority.

5. **Road No. 14 (Guru Ravi Dass Marg)**

- a. Drain cleaning is to be done at places.
- b. Malba (un-claimed) to be removed.
- c. Unauthorised abandoned vehicles to be removed with consultation of traffic police.
- d. At T-Point with Road No.13, improvement of road surface is required.
- e. In front of DDA flats two water pipes are passing through storm water drain resulting chocking of rain water flow. The matter may be taken up with DJB to remove the same. If required, by pass may be provided in the drain.
- f. Additional pipe of bigger size may be provided from T-Junction towards road No. 13 to drain off rain water.
