A inspection of the above work at Ramp 'G' opposite Soochna Bhawan was carried out by Shishir Bansal, Project Manager, Flyover Project Circle F-12, on 08.08.2014 at 09:30 AM. Following were present:

Following issues have been observed and actions decided for strict compliance by the field unit and construction agency.

- i. Shifting of BSES Cables at Jangpura (Ramp 'G'): It is explained that the work will be started by BSES shortly and will take about a fortnight to finish the work
- ii. Shifting of temple at Ramp G (RG11): EE is requested to take up the issue with Mandir Pujari for getting it shifted on priority. Any assistance required by Pujari for shifting the temple and sheds may be extended by the construction agency.
- iii. Removal of 20 trees: 20 trees falling outside the alignment are required to be shifted for movement of machinery during the

launching of segments. M/S AFCONS are requested to explore the possibility of alternative solution to launching to avoid shifting/removal of these 20 trees. Further, it is observed that number of trees to be removed can also be reduced drastically. EE to attempt to reduce the trees for removal and initiate the case of necessary permission from Forest Department.

iv. The launching of segments can be started shortly. The agency is requested to erect the launching arrangements and shift the segments to site to start the launching of segments

The Executive Engineer directed to submit the action taken report within a fortnight of the issue of this inspection note.
