The work "C/o 40 Nos. SPS type additional Class Rooms at Govt. S.K.V. Old Seemapuri, Delhi" was inspected. The progress of the work is about 92%. The E.E. was asked to take action as per provisions in the agreement & ensure that work should be completed by 30.09.14.

The work "C/o 20 nos. double storeyed SPS type class rooms, 2 nos. staircase, 2 nos. toilet block at GGSSS Saboli, Delhi" was inspected. The progress of the work is about 80%. The targets given by the agency are not being adhered. The E.E. was asked to take action as per provisions in the agreement & ensure that work should be completed by 30.09.14.
